EARTH HOME BUY & WIN CONTEST 2024

Terms and Conditions

- 1. Earth Home Buy & Win Contest ("Contest") will run from 1 January 2024 to 29 February 2024 ("Contest Period"). Earth Home Products (Malaysia) Sdn. Bhd. ("Organiser") reserves the right to shorten or extend the Contest Period without prior notice. The Contest will run for eight (8) Contest Weeks as follows:
 - a. Contest Week 1: 01 January 2024 11 January 2024;
 - b. Contest Week 2: 12 January 2024 18 January 2024;
 - c. Contest Week 3: 19 January 2024 25 January 2024;
 - d. Contest Week 4: 26 January 2024 01 February 2024;
 - e. Contest Week 5: 02 February 2024 08 February 2024;
 - f. Contest Week 6: 09 February 2024 15 February 2024;
 - g. Contest Week 7: 16 February 2024 22 February 2024;
 - h. Contest Week 8: 23 February 2024 29 February 2024.

All entries must be received by the Organiser by 11:59pm on 29 February 2024. Late entries will be disqualified.

- 2. This Contest is open to all citizens and permanent residents of Malaysia age 18 years and above (as at 1 January 2024) except the employees and immediate family members of the employees of the Organiser, including its affiliated and/or related companies, distributors, dealers, advertising and promotion agencies.
- 3. To participate in the Contest:
 - a. Purchase RM15.00 and above worth of Earth Home products in a single receipt at any participating outlet (physical or online) within the Contest Period. One (1) receipt entitles the participant to one (1) WhatsApp entry only. Every RM15.00 entitles the participant to one (1) Contest entry, eg:

 - iii. Full name as per NRIC.
- b. Retain the original receipt dated within the Contest Period with matching receipt details as per WhatsApp entry as proof of purchase.
- c. Participants may send as many WhatsApp entries as they wish but each entry must be accompanied with the required details and a different receipt for each entry.
- d. Participants are not allowed to send more than one (1) WhatsApp entry with the same receipt to the Organiser.
- e. In the event the same receipt is received by the Organiser in multiple entries, the earliest entry received shall be taken into consideration. The Organiser shall have the absolute discretion to reject any other entries thereafter with the same receipt whether it is with a different participant's name or otherwise.
- f. Only original and valid receipts with clear and complete details and product description will be accepted. Manual and handwritten receipts will not be accepted. Any receipt that is illegible, mutilated, altered, duplicated, re-printed, tampered with, not obtained legitimately, contains printing typographical, mechanical or other errors or the printing is unclear or does not contain the required information is invalid and will not be

- accepted. The Organiser reserves the absolute right to disqualify any such invalid receipts without any prior notice.
- g. During the Contest Period, each Contest Day begins at 12:00am and ends at 11:59pm.
- h. In view that the line 017-3244341 is a special line provided by the Organiser, no acknowledgement of receipt will be sent by the Organiser with regard to entries submitted/sent from the participants to the Organiser via WhatsApp. Any enquiry/call to the line will not be entertained. For enquiry, participants may contact Earth Home at 03-77342118 (call) or 011-24387514 (WhatsApp), Monday to Friday, 9.30am to 5.30pm, excluding Selangor state and Public Holidays.
- i. The Organiser will not reimburse the participant for any charges incurred in submitting the entries, if any.
- j. Participants are permitted to participate in this Contest using a registered Malaysia mobile number and via the use of mobile phones only.
- b. The Organiser and the companies involved in this Contest shall not be held liable in any way for any delay, non-delivery and/or interruption of WhatsApp messages sent and shall not be held responsible for any unauthorised use of the mobile phone or subscriber's account in conjunction with the Contest.

4. Winners' selection:

- a. Grand Prize x 1 and First Prize x 1:
 - i. The Grand Prize and First Prize winners will be determined by the total number of qualified Contest entries received during the Contest Period divided by 2.5, for example, if the total number of qualified Contest entries is 10,001, then this number will be divided by 2.5 and rounded to the nearest lower whole number which is 4,000. Hence the 4,000th and 8,000th qualified entries will be shortlisted and stand to win the Grand Prize and First Prize respectively. In the event the shortlisted entry is disqualified, the next earlier entry will be the replacement winner, for example, the replacement winner for the 4,000th qualified entry is qualified entry 3,999th.
 - ii. The eligible Grand Prize winner (entry 4,000th from example above), will be invited to Klang Valley (Malaysia) to participate in an event to determine whether the participant is a Grand Prize winner. In the event the eligible Grand Prize winner does not win the Grand Prize, he/she will win the First Prize and the Grand Prize will be forfeited. When this happens, entry 8,000th will not win any prize. All travel costs and personal expenses incurred in participating in the event will be borne by the participant.
- b. Weekly Prize x 3 winners x 8 Contest Weeks:
 - i. The eligible Weekly Prize winners will be determined by the total number of qualified Contest entries received during the Contest Week divided by 18. For example, if the total number of qualified Contest entries received is 1,268, then this number will be divided by 18 and rounded to the nearest lower whole number which is 70. Hence the 70th, 140th, 210th qualified entries and so on will be shortlisted. The 1st, 7th and 13th shortlisted entries will be the eligible Weekly Prize winners for the week. If an eligible winner is disqualified, the following shortlisted entry will be the replacement winner, for example, if the 1st shortlisted entry is disqualified, the 2nd shortlisted entry will be the replacement winner. If the 7th shortlisted entry is disqualified, the 8th shortlisted entry will be the replacement winner.
- c. The eligible winners will be contacted by telephone and will be required to answer a question correctly before being declared a winner. In the event the eligible winner fails to answer the question correctly, the Organiser reserves the absolute right to disqualify the eligible winner. Should the first attempt to contact the eligible winner fail, i.e. no reply, telephone number not in service or no connection, etc, another two (2) attempts will be made within the next twenty four (24) hours of the first attempt. Where such

- further attempts are unsuccessful, the Organiser reserves the right to disqualify the participant. The Organiser shall not be held liable in the event the winners cannot be contacted for whatsoever reasons.
- d. The eligible winners are required to submit to the Organiser all the original receipts and a copy of their NRIC within three (3) working days from the date of notification by Pos Laju/courier, failing which, the eligible winner shall be disqualified. The Organiser shall not bear any postage cost incurred by the winners, and shall not be responsible for any delay, non-delivery or missing post/courier.

5. Contest prizes:
